FIRST AMENDMENT TO SETTLEMENT AGREEMENT

This Amendment is entered into and signed to capture a term agreed to by the Parties, but not memorialized in the initial Settlement Agreement. *See* Settlement Agreement § VIII(I) (governing amendments). As part of the Settlement Agreement, DuPont agrees that, during future inspections, those inspecting properties will record any trees that are observed to show signs of damage from Imprelis®, rather than recording only those trees specifically identified by Property Owners. This obligation shall not be interpreted to require DuPont to revisit a property that has already been inspected as part of the Imprelis® Claims Resolution Process or require the inspectors to visit a portion of the property not indicated by the Property Owner.




